SUMMARY OF THE PROCEEDINGS OF 23rd ANNUAL GENERAL MEETING

- a. The business before the meeting was taken up and the requisite quorum was present throughout the meeting. Total 35 members were present in person and 5 members were present through proxy at the AGM.
- b. Sri V.N. Sunanda Reddy, Chairman, chaired the meeting.
- c. The agenda of the meeting, since already circulated, was taken as read with permission of the members.
